**DEFENDANT PRO SE MOTION FOR NEW HEARING DATE / SUPPLEMENTAL MOTION TO IMMEDIATELY DISMISS  
WITH PREJUDICE IN THE INTEREST OF JUSTICE**

Your Honor,

*Sir, today is November 26, 2018 and I just spoke to your assistant at your office on the telephone regarding my former attorney Mr. Whitehead's Motion to Withdraw. I understand it has been granted. I also understand your honor I am still due in court this coming Wednesday.*

*Your honor, I am now without an attorney at this time and I shouldn't be. Additionally, these vengeful charges should not have been filed in Monro County or Dubois County, but since a Indiana State Trooper is based out of the ISP Jasper Post, I get the very special extra hard treatment and the police are using all their political might to press and aggravate this entire disgusting situation perpetrated against me further. I am currently out of bond but continued to be harassed by the police which includes outrageous and reaching false reports of me breaking my bond and leaving the State of Indiana based on some report of seeing someone in my truck in Chicago they know was not me. They were reporting on me being in the Gary/Hobart, Indiana area as if it was some sort of crime to do so. The fact is your honor, I grew up just 10 miles for there and the entire Northwest Indiana area from the Illinois border to Valparaiso, Indiana was once my sales territory when I was a District Sales Manager several years ago with ADP ([www.adp.com](http://www.adp.com)) and I still have family and friends in the area.*

*My former attorney Doug Walton confirmed to me what I already knew and that is Mr. Quinn, the elected prosecutor is also holding on to this charge against me since it is an election year and because the police 'want me bad'. Your honor, I don't believe Mr. Walton had any reason to lie since his own father was also a police officer and at least I can say Doug was no fool in terms of understanding just how sick and depraved some bad police officers can and enjoy being.*

*Your honor, ISP Trooper Gaven Wilson is a disgrace of a police officer and the evidence I have clearly demonstrates that Gaven Wilson among others is a corrupt cop and was clearly investigating me without probable cause for his own personal gain which put me in fear for my life. I have witnesses from church in Montgomery, Indiana that say ISP Trooper has been sexually assaulting women and girls in that community for years using his powers as a police officer to coerce or otherwise intimidate them into it or in my case, run your romantic rival out of town at gunpoint and in fear for his life and then spend years trying to*

*destroy it for reporting him which he does everyday on citizens all over the State of Indiana everyday. Gaven Wilson your honor is one truly sick and vile individual.*

*I never stalked Deanna Raber your honor and her taper testimony proves that. She was involved in a relationship with me until Gaven Wilson and his co-conspirators spread very damaging falsehoods about me from their illegal investigation into me without cause and put the fear of God into her and me as well. He was after me and he is heavily armed and he is a trusted police officer. What chance would I have had on some county back road with Wilson on me with the powers of a Indiana State police officer behind him as well as people willing to turn a blind eye to his many crimes and stop at nothing instead to persecute me, a guy who came to town with a bible in hand and was going to church three days a weeks and I had just returned from flight school where I was learning to be an aerial applicator 'crop duster' pilot. I was involved in no crime whatsoever your honor.*

*What other crimes is Gaven Wilson guilty of your honor? God willing, the FBI will find that out since it appears Wilson is still well connected obviously in Dubois County, why else would I be suffering like this for so long? I have laid hands on no-one your honor and I do not or have not owned any weapons for over 30 years and I served our county with honor as a United States Marine. All I want to do is what I have always wanted and that is to live my life in peace and mind my own business.*

*Your honor, it is my firm position that Mr. Whitehead as well as Doug Walton both broke their fiduciary duty to me in part for some political fear and retaliation from the police who are interested in "destroying me" as quoted directly to me by licensed medical doctor and psychiatrist Dr. Linda Callahan. She is no fool your honor; she understands what these monsters are still working to do to me and what their end game is. Dr. Callahan says they want me to commit suicide and they almost succeeded your honor.*

*Both attorneys expressed a desire to "depose" Trooper Wilson, but when I mentioned I also wanted the other material witnesses deposed as well which includes Deanna Raber and her two sisters, Troy Fuhs of the Daviees County Sheriffs Office as well as other respected members of the community on Montgomery, Indiana which includes fellow church members who also have knowledge of ISP Trooper Wilson's past and present depravity not only as a police officer, but as a human being, both attorneys wanted no part of it but their testimony your honor at trial will be imperative if I am to continued to be prosecuted.*

*Sir, after my call to your office today, I met with an attorney in Jasper about defending me. He says to me "it looks like nothing has been done on your case in six months".*

*Your honor, I would like to point out that besides the frightening incarcerations I have already suffered over this which includes a razor and pipe attack during my 70 days in a Costa Rica rat invested hellhole as the lone American locked up in a grossly overcrowded gang-filled foreign prison as well as 30 days in Cook County Jail in Chicago as well as time in Houston, Texas maximum security in solitary confinement before being extradited to Dubois County where I have been on bond for six months,*

*Your honor, I would also like to point out that these charges against me have kept me from returning to work which I would desperately like to do as well as go home to where I live. Southern Indiana is not my home. I did not grow up here eventhough I have had extended family ties to the area (Pike County) for years. I just want to go home and get on with my life I have been terrorized from living.*

*Your honor, when the case was filed against me for the same phone call allegedly from Nicaragua allegedly made by me that sits before you today in Dubois County was still active as another separate charge in Monroe County and right before my attorney on that case, Joe Lozano of Shapiro & Lozano in Bloomington was finally dismissed with prejudice, the prosecutor in that case had already decided to dismiss it but not before according to my attorney Joe Lozano, the prosecutor received pressure to keep my case alive and not dismissed by certain loyal friends of Trooper Wilson. Thankfully for me it was dismissed and I thought this epic saga of a nightmare was finally over only to find out later that Dubois County now wants to take a bite out of me as well.*

*Your honor, I have been a special target for law enforcement for my reporting on ISP Trooper Wilson to the proper authorities and everyone with a heartbeat knows how police officers cover from one another and uphold the "Blue Wall of Silence". They have been tormenting me and my family with lies for years. Gaven Wilson is a criminal and he is the one who needs to spend some time behind bars. Why do you think sir that an Assistant Director of Intelligence with the DEA told me to enjoy my life down South and walk away from this if I could? It is because he knows this I reality is and has been life threatening for me and everyday this continue the metal stress brings me that much closer to a final death over this your honor. I am finally in a better place mentally now after my time and treatment by Dr, Callahan. Please your honor, I am very close to another serious mental breakdown and yet another possible stay I really don't need or deserve locked in the hospital. I just need to finally be free of this and head home and get on with what life I have left they have stolen from me.*

*Your honor, I humbly pray and ask once again to dismiss this outrageous, cruel and vengeful case against me with prejudice. If that is not possible sir, I ask that I be given a new hearing date to prepare to defend myself as a pro-se defendant because it is obvious I am not going to get any lawyer who has not heard of my case and doesn't feel the weight that the power the police bring to the table against anyone who has speaks out as truthfully and loudly as I have against their criminal activity in public.*

*Please your honor do not let them punish me or my family any further your honor for their own depravity and corruption and my need to defend myself from such aggression. This really sick part of this your honor in my view and my family is that I have never even met this maniac Gaven Wilson in my entire life and to think I have been through 12 years of hell over this piece of garbage is a horror story one can not make up and in the end I have been told by many, needs to published as a book and my story told.*

*It is absolutely unbelievable your honor. Please end this nightmare and this belligerent case against me.*
